

# LP/LT INSTALLATION INSTRUCTIONS

### **INSTALLATION**

This beacon is designed to comply with IP67 when correctly installed. To ensure a weatherproof installation the beacon must be fitted with the foam gasket provided and mounted on a flat panel or surface forming part of a weatherproof enclosure. The panel or surface should be drilled to accept the wires and M5 studs (see drilling for panel mounting). Secure the beacon with the nuts provided (max torque 5 Nm). The power supply to the beacon must be fitted with a 500mA fuse.

IMPORTANT: When the beacon is mounted on a metal panel or bracket, the panel or bracket must be connected to earth. If an insulating panel or bracket is used then access to the insulated wires of the beacon must be prevented, either by using an insulating sleeve or by means of a suitable insulating barrier.


- 1. Proper installation combined with operator training in the use, care, and maintenance of emergency warning devices are essential to ensure the safety of you and those you are seeking to protect.

**Caution:** When drilling into any vehicle surface, make sure the area is free from any electrical wires, fuel lines, vehicle upholstery, etc. that could be damaged




## MULTI-VOLTAGE BEACON

20V - 72VAC


## MAINS BEACON

On DC units it is possible for Asynchronous operation (alternating flash) by connecting the beacons in the configuration below.





### **DRILLING FOR PANEL MOUNTING**




### SYNCHRONISATION (if fitted, XENON type only)

The Xenon beacon fitted with the yellow wire is capable of synchronisation. Installation details and options below.



#### STEADY BURN (if fitted, LED type only)

The LED beacon fitted with the yellow wire is capable of steady burn. Beacon will flash if yellow wire is not connected. Connecting the yellow wire to ground will cause the beacon to run in the constantly lit mode. Details below.
