

Installation and Operation Instructions SILVER ECCOLED R65* LED Beacon

The Silver ECCOLED R65 Beacon utilises powerful LEDs, arranged to produce a 360° flash pattern with a flash rate of 125FPM for maximum visibility by combining the solid-state, maintenance free long-life nature of LED technology. This high-performance range has increased EMC, is robust and compact in a popular housing design and is available in four standard mounting options. The ECCOLED range of beacons are suitable for a variety of vehicles including applications where the UK lighting regulation Chapter 8 is a requirement*. This range is designed to maximise resilience to excessive vibration, increase the life of the product and are backed by a three-year warranty.

- 5. Do not install this product or route any wires in the deployment area of an air bag. Equipment mounted or located in an air bag deployment area may reduce the effectiveness of the air bag or become a projectile that could cause serious personal injury or death. Refer to the vehicle owner's manual for the air bag deployment area. Important! This unit is a safety device and it must be connected to its own separate, fused power point to assure its continued operation should any other electrical accessory fail.

Caution: When drilling into any vehicle surface, make sure the area is free from any electrical wires, fuel lines, vehicle upholstery, etc. that could be damaged



Notes:

- 1. Larger wires and tight connections will provide longer service life for components. For high current wires it is highly recommended that terminal blocks or soldered connections be used with shrink tubing to protect the connections. Do not use insulation displacement connectors (e.g., 3M Scotchlock type connectors).
- 2. Route wiring using grommets and sealant when passing through compartment walls. Minimize the number of splices to reduce voltage drop. High ambient temperatures (e.g., under-bonnet(hood)) will significantly reduce the current carrying capacity of wires, fuses and circuit breakers. All wiring should conform to the minimum wire size and other recommendations of the manufacturer and be protected from moving parts and hot surfaces. Looms, grommets, cable ties, and similar installation hardware should be used to anchor and protect all wiring.
- 3. Fuses or circuit breakers should be located as close to the power takeoff points as possible and properly sized to protect the wiring and devices.
- 4. Particular attention should be paid to the location and method of making electrical connections and splices to protect these points from corrosion and loss of conductivity.
- 5. Ground termination should only be made to substantial chassis components, preferably directly to the vehicle battery.
- 6. Circuit breakers are very sensitive to high temperatures and will "false trip" when mounted in hot environments or operated close to their capacity.

3 BOLT FIXING VERSION

TO ENSURE A WEATHERPROOF INSTALLATION THE BEACON MUST BE FITTED WITH THE SUPPLIED GASKET AND MOUNTED ON A FLAT PANEL OR SURFACE FORMING PART OF A WEATHERPROOF ENCLOSURE.

Drill the panel or surface to accept the wires and the 3 M6 screws (see figure 1).

Connect the 2 wires to an appropriate power source ensuring that the RED wire is connected to the POSITIVE terminal of the supply via a suitable 3A fuse.

Fit the fibre washers under the screw heads to prevent water ingress and fix using the shakeproof washers and nuts. The rubber grommet supplied may be used to protect the wires when the beacon is panel mounted. The grommet is designed to fit a hole 6mm dia with panel thickness of 1.5-2mm.

SINGLE BOLT FIXING VERSION

TO ENSURE A WEATHERPROOF INSTALLATION THE BEACON MUST BE FITTED WITH THE SUPPLIED GASKET AND MOUNTED ON A FLAT PANEL OR SURFACE.

Drill the panel or surface to accept the M12 threaded bolt.

Fit the beacon in the required position, first passing the wires and bolt through the pre-drilled hole. Secure using the M12 half nut and washer supplied.

Connect the 2 wires to an appropriate power source ensuring that the RED wire is connected to the POSITIVE terminal of the supply via a suitable 3A fuse.

MAGNETIC BASE VERSION


THE BEACON MUST BE FITTED ON A FLAT PART OF A STEEL ROOF OR PANEL.

Check that the vehicle battery voltage is compatible with the beacon to be fitted. The connection to the beacon must be fitted with a suitable 3A fuse.

Wipe the roof of the vehicle where the beacon is to be placed to remove any debris or grease, and ensure that the foam gasket is clean, dry and in good condition. Place the beacon in the required position and connect to the vehicle battery supply using the cigar plug.

Note: In appreciation of the Consumer Protection Act 1987, covering product liability, and because of the nature and use of magnetic beacons, ECCO are obliged to make the following maximum speed recommendation for vehicles fitted with magnetic beacons:

WE CAN ONLY RECOMMEND THE FITTING OF A ECCO MAGNETIC BEACON IF THE VEHICLE TO WHICH IT IS FITTED DOES NOT EXCEED A SPEED OF 70 M.P.H. FOR SPEEDS BETWEEN 40 AND 70 M.P.H., WE RECOMMEND THE USE OF A SUITABLE RESTRAINING DEVICE.
